Band Parent Contract AND Fall Marching Band Student Contract 2024-2025

Deposit and Contract Due Date: \$100 due June 18th OR \$144 dollars if you need to purchase marching band shoes. Check with your student to see if they still have shoes, even if they participated last year. (paying by check, please write your student's name and "Payment #1" in the memo field)

This contract only addresses the Glen Allen High School Marching Band, including Woodwinds/Brass/Percussion and Fall Color Guard. Other winter activities including winter colorguard have their own contract and a separate fee. Marching Band fees pay for things like instructors, competition fees, instruments, etc. There are no refunds for Marching Band fees. All payments made are automatically applied to the oldest fees owed. *There is a \$50 discount per student (on the final fee) for families with multiple children in the band.

Parent/Guardian Statement of Commitment:

"I (parent or guardian) understand that by signing this contract, I am 100% committed to the Glen Allen High School Band Boosters and the Glen Allen High School Marching Band. Specifically, I will fulfill my financial obligations listed below and ensure that my child upholds his/her obligations to the Glen Allen High School Marching Band. These include, but are not limited to, all time commitments involved such as practices, competitions, and football games, as well as addressing and upholding the standards for attitude and discipline as stated in the Glen Allen High School Band Student Handbook. I will also strive to attend all monthly Band Booster Meetings.

By opting in to the fundraising plans, students are required to meet the following obligations:

- Participate in the annual email fundraising campaign**
- Sell at least two tickets to Bingo night**
- Work a minimum of one shift during one of the major fundraisers (Bingo, Talent Show, Spirit Nights, etc.)**

If I choose to opt out of the above fundraisers, then I understand that I must pay payment #4 which is \$150. If fees are not paid, my child and I will be ineligible to participate in all future Marching Band activities to include end-of-year banquets, trips, and subsequent seasons."
